A. Call to Order: The meeting was called to order by Jeff Creger at 01:36 P.M. It was determined that a quorum was present.

B. Order of Business:

1. **Approval of Consent Agenda:** Mary Ingham made a motion to approve the December 16, 2008 consent agenda, seconded by Laura Cerny, motion carried.

D. Revenue and Expenditures-Review

1. **The Financial Report** Cody reviewed, but paper copy was not printed for packet.

E. Local Empowerment Board Programs

1. **Preschool Scholarship Program:** We have received in the office as of 12/08/2008 140 applications or requests for applications. As of 12/08/2008 we have 122 children approved for services. With a total of \$95,045 allocated to these scholarships. 5 family waiting on more information to verify if family qualifies. We have denied 3 families; 2 families were denied due to residence out of the three counties, and 1 denied for too high of income. We have closed 3 scholarships due to families moving out of the area. Our budget for the 2008-2009 year is \$100,000, and have \$4,955 left to allocate to families. As of 12/08/2008 we have paid out \$26,575 to preschools for the month of September to November.

2. **Outdoor Learning Environments:** As on 12/08/2008, we have 12 applications in house, and a few more that have called about sending one in. The deadline is December 19th.

Radio Ad's: January 5th to February 23rd. Each Day 6a-7p: 1 Quality Childcare Ad will run and 1 Preschool Ad will run on the Following Stations: 107.3, 98.7, 103.7. Will have 2 interviews on each station over the 2 months. Cost \$1,100.00.

4. **Preschool Survey:** As of 12/08/2008, we have 292 surveys returned and entered. Still missing a few surveys from a couple of preschools. Preschools that have not reported at all (have contact, but have not received information): Tugs Daycare and Preschool, Charlie Brown West town and East Town. Have sent out enrollment sheets to verify names and statistics on each preschool.

5. **Preschool Training Funds:** Waiting on more information.

6. **Program Observations:** Observed: Stebens ABCD Drama at Washington Early Childhood Center on October 8th. Nurse Consultant at Discovery Time Preschool October 27, and Clear Lake Home Provider November 10. Preschool Transportation at Washington Early Childhood Center November 20.

The Mason City School is still creating a Family Support program and is hoping to start in March.
- 5. Contracts-School District Programs:** Laura Cerny made a motion for a conditional contract for Head Start to do a Family Support Program for the 4 school districts (Clear Lake, Garner-Hayfield, Northwood-Kensett, and Manly) and seconded by Kristi Parks, motioned carried.
